**SUGARBUSH CHILDREN'S SKI & RIDE PROGRAM**  
**Express Assumption of Risk and Form Selection Agreement**  
**(PLEASE READ CAREFULLY!)**

**SUGARBUSH RESORT WILL NOT ADMINISTER MEDICATION OF ANY KIND TO CHILDREN.**  
**SUGARBUSH RESORT IS NOT RESPONSIBLE FOR LOST OR MISPLACED CLOTHING OR EQUIPMENT.**

I understand that all forms of alpine activity are hazardous with many inherent dangers and risks, and that injuries are a common and ordinary occurrence in these activities. By allowing my child to participate in this Program, I acknowledge my child's progressive participation and I expect that in order for my child to move to the next progressive skill level, the Instructor will challenge my child continuously during the Program. I acknowledge that such challenges and progressions are inherent in the Guest/Instructor relationship and in the learning process. I further understand that the nature of ski/ride lessons often requires children to ride ski lifts by themselves (ages 6+) and/or with members of the general public.

I, on behalf of myself and my heirs, further agree that the phrase "inherent risks" means those risks which are listed in this Agreement, or those that can reasonably be inferred therefrom. I also agree that these risks are both obvious and necessary to these winter sports activities. I agree that the inherent risks of winter sports include but are not limited to changing weather conditions; surface and/or subsurface snow conditions as they may from time to time exist and may change or be affected by weather, skier, or participant usage (whether such conditions are surface or subsurface, consist of ice, hard pack, powder, packed powder, wind pack, corn, crust, slush, cut up snow, and/or machine made or machine enhanced snow); other risks and/or conditions including bare spots, forest growth and debris, stumps, trees, streambeds, water and/or water bars, and other such conditions, whether or not they are visible, and/or collisions with such objects; collisions with lift towers, signs, posts, fences, or other enclosures, water and/or air pipes or other manmade structures, and/or their components such as pipes and hydrants used in snowmaking or for other necessary purposes, whether or not these structures are marked, padded, or shielded; collision with well-marked or plainly visible snowmobiles, snow grooming, or other over-snow vehicles or equipment; collisions with skiers, riders, or others; variations in steepness of terrain including but not limited to roads, terrain modifications, features or variations which occur naturally or as the result of slope design, feature design, weather events and/or changes, snowmaking and/or snow grooming operations, and/or participant usage.

In consideration of Summit Ventures NE, LLC, d/b/a Sugarbush Resort, hereafter "Sugarbush," accepting my above named child in the program. I hereby indemnify and hold harmless Sugarbush, its agents, officers, directors, owners and employees to the fullest extent allowed by law, of and from any and all liability for personal injury or death or property damage which arises from my child's participation, which includes but is not limited to any inherent risks identified above as well as my child's placement in a skill level, the selection of specific terrain and/or instructor or the physical exercise and/or activities which my child will be directed to do as part of my child's participation.

**I FURTHER AGREE THAT ANY CLAIM WHICH I MAY AT ANY TIME BRING FOR ANY REASON AGAINST SUGARBUSH, OR ANY OF IT'S AGENTS, OFFICERS, DIRECTORS, OWNERS AND EMPLOYEES OR ANY DISPUTES ARISING OUT OF MY CHILD'S PARTICIPATION IN THIS PROGRAM SHALL BE SUBMITTED TO THE JURISDICTION OF THE STATE OR FEDERAL COURT IN THE STATE OF VERMONT, AND THAT NO CLAIM OR ACTION SHALL BE BROUGHT IN ANY OTHER JURISDICTION.**

I give permission to Sugarbush to call a doctor and to transport my child to the nearest physician or medical center in the event of an injury or medical emergency and authorize first aid and or emergency treatment from qualified persons should the need arise. I hereby authorize Sugarbush to provide my child with rental equipment maintained by Sugarbush for any part of and/or duration of a lesson should the need arise for alternate equipment to that which I provided. I give Sugarbush permission to apply sunscreen to my child and to transport my child via chairlift or public bus service between the Lincoln Peak and Mount Ellen areas for Program activities. Sugarbush Resort is not responsible for lost/misplaced items and all items should be marked with your child's name.

I also hereby consent for all purposes to the sale, reproduction, and/or use of photographs, video and/or film of me or my child (with or without the use of my/our names) by Sugarbush and any designee (including any agency, client, or periodical) in all forms and media in all manners including media production or printed materials, without compensation. I Release the photographer, Sugarbush, and of its designees from any liability which may occur as a result. I hereby agree that I shall not make any claim for compensation the use of these likenesses in any of the foregoing media.
